



## **I**OPERATIONS

### ASSEMBLY


- 1. Connect the main unit of the handheld vacuum cleaner to the extension tube;
- 2. Connect the extension tube with power brush.


### **CLEANING**


- 1. Push the power button to start cleaning. The first position is low speed for floor cleaning, and the second position is high speed for carpet cleaning;
- 2. Before use, it is necessary to clean up large or sharp objects (such as screws, etc.) in the area, and start cleaning by moving the power brush back and forth:
- 3. After use, slide the button to the off position.



### ASSEMBLY OF STORAGE BASE

Install the storage bracket and the storage base according to the position shown in the figure, and place the assembled storage base on a horizotal surface according to the right picture.






### **IOPERATIONS**

### PLACEMENT OF THE MACHINE

### **A**CAUTION

- 1. The machine must be placed on a level surface before placing it on the storage base or when the storage base is placed separately, so as to avoid tipping and damaging the machine;
- 2. Regardless of whether the machine is working or placed on the storage base, always handle with care to avoid damage to the machine.
- 1. Press the release button on the upper end of the extension tube to separate the main unit from it:
- 2. Keep the extension tube connected to the it power brush, and place the brush on the corresponding position of the storage base, as shown in the right figure;
- **3.** Align the groove at the air outlet of the main unit with the buckle of the storage bracket, and fix the main unit on the other side of the storage bracket. The power cord can be wound around the winding hooks of the extension tube.



### DISASSEMBLY AND CLEANING OF THE DUST CUP

### **A**CAUTION

To maintain the suction power of the vacuum cleaner, please clean the dust regularly.


Remove the dust cup assembly as shown in the figure, then remove the upper cover of the dust cup through the metal pull ring and dump the dust.




### DISASSEMBLY AND CLEANING OF THE FILTER

### A CAUTION

- 1. Filter cotton is washable:
- 2. Please make sure that each part is fully dry before installing after cleaning.
- 1. Push the cover release button on the top of the main unit to open the cover:
- 2. Take out the two pieces of filter cotton upwards, shake off the surface dust, rinse with water and dry it in the sunlight for 24 hours;
- **3.** After the filter cotton is dried, reinstall it in the machine and put back the upper cover.






DISASSEMBLY AND CLEANING OF THE POWER BRUSH

### **A**CAUTION


- 1. In order to avoid affecting the operation of the power brush, perform cleaning and maintenance when the roller brush or wheels are entangled or dirty;
- 2. Before disassembling and maintaining, be sure to stop the operation of the power brush.
- 1. Entangled hair can be cleaned with scissors or blades, as shown;



2. For debris that is not easy to clean, you can use a flat-blade screwdriver or a coin to turn the knob to the unlock position, and open the brush plate for cleaning. The details are shown:



**3.** After cleaning, reinstall the brush plate, insert one end of the plate into the hole position of the brush, press the other end of the plate into the matching hole, and turn the button to the locked position to complete the installation; Details are shown.






- 1. 将手持吸尘器主机与金属接插管相连;


### 清扫


- 1. 推动滑动开关开始清扫,第一个档位为低速档适用于地板清洁,第二个档位 为高速料适用于地毯清洁:

- 3. 使用完成后,将开关滑动至关闭位置。



### 收纳架组件的安装

将收纳支架组件与收纳底座组件按图示位置安装好,并将装好的收纳架组件按右 图竖直放置在水平面上。





整机的放置

### **▲**注意



按图示取下尘杯组件,再通过金属拉环取下尘杯上盖倾倒灰尘。




### 过滤器拆解及清理

### ▲注意

- 1. 过滤棉为可水洗件;

- 2. 向上拿出两块过滤棉,抖掉表层灰尘,用水冲洗后阳光下晾晒24h;
- 3. 过滤棉晾干后重新装回机器,装回上盖。






电动地刷拆解及清理

### **▲**注意


- 1. 为避免影响电动地刷运转,当滚刷、轮子被缠绕或脏污时,请进行清洁保养;
- 2.拆解保养时,请务必停止电动地刷运转。
- 1. 缠绕毛发可用剪刀或者刀片清理,详情如图所示;



**2.** 对于不容易清理的碎屑,可以使用一字螺丝刀或者硬币旋转旋钮至开锁位置, 打开地刷底板进行清理,详情如图所示;



3. 清理完成后重新安装地刷底板,将地刷底板一端卡扣插入地刷孔位,将地刷底板 另一端压入配合孔中,旋转按钮至锁紧位置完成安装;详情如图所示。
